Throughout her career, she has been a speaker for NCUA, CUNA, The World Council of Credit Unions, and PCUA.



CREDIT UNION CHANGES DORMANT ACCOUNT POLICY

Starting January 1, 2015, the Credit Union changed the Dormant Share Account Policy. A member's account is considered dormant if no activity has taken place on the account for one year.

When the member has a dormant account for a period of one year, the Credit Union will send a notice to the member at the mailing address on file. Members will be notified by letter of the dormant status and encouraged to do one of the following:

- Activate the account with deposit or withdrawal
- Close the account

If the member chooses neither of these options after 30 days, the Credit Union will begin to assess a monthly fee of \$5.00 per month. The fee will continue until there is activity on the dormant account or the balance is depleted. After three years, if the account still has a balance with no activity, the account will be escheated to the State of Pennsylvania. The exceptions to this policy are if the member has other accounts under the same account number or the member is under 18 years of age.

The Credit Union will make the necessary attempts to contact members with dormant accounts. This makes it essential that mailing addresses on all accounts be current and up to date.

2015 CONTINUING EDUCATION AWARDS

Mercer County Community Federal Credit Union will present their 15th Annual Continuing Education Awards at the Annual Dinner Meeting on April 25, 2015. The awards total \$4,000 and are for the 2015-2016 academic year. They are open to any 2015 high school senior or any student between ages 17 and 25 who is in pursuit of an academic, professional, or vocational post-high school education at a college, university, or accredited trade school. Applicants must be a member of the MCCFCU prior to submitting their application.
