You can have Social Security, pensions, annuities, military checks, and even IRS refunds deposited directly into your Credit Union account. You'll need to use the credit union routing number 2433 8496 5 and your account number to set up direct deposit. To verify your credit union account number, please call either office.

CONVENIENCE ON THE GO...MOBIL F BANKING AND MOBIL F CHECK DEPOSIT!

With Mercer County Community FCU Mobile Banking, you can access your account no matter where your travels take you. So leave your laptop at home – your Credit Union is already with you – safe and secure, on your smartphone.

If you haven't signed up for Mobile Banking, it's easy to get started. First, you need to be signed up for home banking before you can activate mobile banking. Once you have home banking, simply follow the steps below.

To start the process, log on to home banking through your home computer. Go to MANAGE ACCOUNTS and click on ACTIVATE MOBILE DEVICE. Scroll down to CREATE NEW ACTIVATION CODE. Then search the App Store or Google Play on your smartphone to download the mobile banking app for Mercer County Community FCU. Once you've downloaded the app you can log in to home banking using your mobile phone with your account number, password, and activation code. From here, simply follow the step by step instructions to start using the app.
