Eligibility: This drawing is open to members and non-members age 18 years and older of Mercer County Community FCU, 428 Sharpsville Avenue, Sharon, PA and 559 North Hermitage Road, Hermitage, PA. Mercer County Community FCU employees, officials, and immediate family members are not eligible to participate in this drawing. Winner must sign and return to the Credit Union an affidavit of eligibility and liability/publicity release to claim prize. All Federal, State, and Local regulations apply. Void where prohibited.
