Eligibility: This drawing is open to members and non-members age 18 years and older of Mercer County Community FCU, 559 North Hermitage Road, Hermitage, PA and 428 Sharpsville Avenue, Sharon, PA. Mercer County Community FCU employees, officials, and immediate family members are not eligible to participate in this drawing. Winner must sign and return to the Credit Union an affidavit of eligibility and liability/publicity release to claim prize. All Federal, State, and Local regulations apply. Void where prohibited.

Prize: Five winners will each receive one (1) \$500 Visa Gift Card on June 3, 2024. Five (5) registrants from combined entries from both branch locations listed above will be chosen to win the prizes. The odds of winning are based upon the number of entries received. Registration will begin on May 1, 2024 and run through May 31, 2024. The winning names will be drawn at random on May 31, 2024. Prizes cannot be substituted, converted to cash, assigned, or transferred by the winners. In addition, each winner selected will choose a 501(c)3 non-profit organization and the Credit Union will make a donation in the amount of \$500 to that organization. In the event that a 501(c)3 organization is not chosen, the Credit Union reserves the right to choose one.

Entry: Entry forms are available at both Credit Union locations listed above. You may also enter by sending a 3"x 5" postcard containing your name, address and phone number to "Grand Opening Giveaway" c/o Mercer County Community FCU, 428 Sharpsville, Avenue, Sharon, PA 16146. All entries must be received by May 31, 2024. You may also drop off your entry at either branch location. The Credit Union is not responsible for lost, late, misdirected, damaged, incomplete, or illegible entries. Once submitted, entries become the sole property of Mercer County Community FCU and will not be acknowledged or returned.

Drawing and Notification: The winner will be determined by a random drawing from all eligible completed entries. The drawing will be conducted by representatives of Mercer County Community FCU. The drawing will take place at the end of the business day on May 31, 2024, and the winner will be notified by phone or mail. If a potential winner cannot be contacted within three (3) days, or if he/she fails to sign and return the declaration and release, he/she will be disqualified, and an alternate winner will be selected. Mercer County Community FCU reserves the right to cancel, suspend, and/or modify the drawing if any factor beyond the Credit Union's reasonable control impairs the integrity of the drawing. The winners' name will be available at the Credit Union after May 31, 2024 and published in the Fall 2024 newsletter.
